To the Committee Chair:

I am requesting a review of the decision dated June 11, 2019, which I received on June 20. This letter is not consistent with a May 20th telephone conversation I had with someone at your office who said that my April 11th complaint against Alan L. Fuchsberg, Esq. was being investigated. I asked if this meant the complaint passed the first level of scrutiny and the answer was in the affirmative. This raises the possibility that my allegation was investigated and it was decided to unlawfully suppress what was learned by misrepresenting my complaint against Mr. Fuchsberg.

Secular universities and colleges in the United States promote an ignorant and stupid concept of God. Their motivation, I suppose, is analogous to whatever motivated French revolutionaries, Nazis, and Communists to kill so many people. The ignorant concept of God is that God created the universe. This is like saying God created Santa Claus. It is irrational even to say that human beings created Santa Clause because we don't know what figments of human imagination are. The universe is a collection of molecules. It is many beings, not one being. Like Santa Claus, the universe only exists in the minds of humans who use the word *universe*. The knowledgeable and intelligent concept of God is that God created human beings. I am a single unified being, not a collection of molecules. I think, therefore, I am. Or, as Descartes put it: *cogito, ergo sum*.

On September 15, 2016, I sent an email to Jewelnel Davis, the Campus Minister of Columbia University, offering to give a lecture/lesson on God's existence. Jane Booth, the General Counsel of Columbia University, responded to this offer with a letter threatening me with legal action if I contacted anyone else at Columbia U. Lee Bollinger, the President of Columbia University, ignored my request for support, and I filed a First Amendment lawsuit against the Attorney Grievance Committee, Lee Bollinger, and Jane Booth (docket no. 17-cv-00703-PKC). I filed a motion for a default judgment because the attorney for Columbia University announced his appearance for Mr. Bollinger one day before the summons was served on Mr. Bollinger. Judge Castel dismissed the lawsuit, and I appealed to the United States Court of Appeals for the Second Circuit. My request for oral argument was granted, and I explained to the chief judge (Robert A. Katzman) and two circuit judges why my proposed lecture/lesson has social value. The district court's decision was upheld, and my petition to the Supreme Court of the United States was denied. I then filed a misconduct complaint with the Judicial Council of the Second Circuit against Judge Castel for not signing the default order. Judge Katzmann wrote the order dismissing this complaint, and I sent the four-page letter included in my complaint against Mr. Fuchsberg to every member of the U. S. House of Representatives.

Concerning Mr. Fuchsberg's misconduct, it altogether understandable that an attorney practicing in New York does not want to get involved in an accusation of misconduct against 16 federal judges. Concerning the misconduct of Judge Castel, it is understandable the he could not wrap his head around the idea that Columbia University needs a retired high school teacher to explain the concept of God. Judge Katzmann's behavior, however, is less forgivable because he heard me explain the argument for God's existence and he wrote the misleading orders upholding the dismissal of the lawsuit and dismissing the misconduct charge against Judge Castel.

The district judge, the appellate judges, and the 12 judges on the Judicial Council of the Second Circuit are violating my right to free speech and thereby preventing the Columbia community from learning the correct concept of God. The 17th villain is whoever caused the June 11th letter to be mailed on June 18 or June 19.
