On January 18, 2016, I gave oral argument to the U.S. Court of Appeals for the Second Circuit in my lawsuit against Columbia U. for threatening me with legal action if I offered to give a lecture/lesson about God's existence to its 12 Religious Life Advisors (docket no. 17-818). In August, 2018, I faxed and mailed the attached 4-page letter to all members of the House of Representatives asking them to protect my rights. On March 2, 2019, I made the same request to the New York Civil Liberties Union. NYCLU did not accept my offer to give them my lesson/lecture. I explain in the attached letter to the NYCLU dated March 21 why my lesson/lecture has social value. I then contacted the deans and administrative bodies of New York Law School, NYU School of Law, Columbia Law School, and Cardozo School of Law suggesting they could be of service to the NYCLU by hosting my lecture/lesson. I accompanied the emails and faxes with the attached lesson plan. In gathering the contact information of the Touro College Jacob D. Fuchsberg Law Center, I discovered that Alan Fuchsberg's law firm offers free consultation and online chat. On April 6, I entered into an exchange with the firm's associate about my concerns. On April 7, I sent the attached email to the Dean and Associate Dean of the Touro Law Center. At 9:58 AM, April 8, I sent the attached fax to Alan Fuchsberg. At 2:30 PM, April 8, I got the attached email in response. My charge of unethical conduct by Alan Fuchsberg is in my response to this email. I'm assuming that Alan Fuchsberg instigated this email, so I deleted the name of the person who actually sent it. The email is so irrational and non-responsive that I consider it to be some kind of hoax.
