Dear Ms. Fischman,

Jorge Dopico sent me a letter dated July 26, 2019, saying that an “independent board of lawyers and non-lawyers” got my entire file, that a reconsideration has taken place, and that the “Committee Chair” is in agreement with the original decision.

I don't believe Mr. Dopico has given my June 21 letter requesting reconsideration to anyone for three reasons. The first is that the Attorney Grievance Committee is a defendant in the lawsuit that has been unlawfully dismissed and is at the root of my complaint against Mr. Fuchsberg. The second is given in my letter of requesting reconsideration. The third is that in our telephone conversation on July 25, 2019, you knew nothing about my request for reconsideration.
