Re: Letter to Congressman Bob Goodlatte dated August 13, 2018

Dear Mr. Marchant,

I faxed the above four-page letter to you on August 16. The letter asks the House of Representatives to use its authority to resolve a conflict arising from a First Amendment lawsuit I filed against Columbia University and the New York State Unified Court System about my offer to give a lecture/lesson on God's existence. I filed a misconduct complaint against the district judge who dismissed the case. The letter explains why the Judicial Council of the Second Circuit's dismissal of my misconduct complaint is malicious. Everyone should know about my lawsuit and the behavior of Columbia University and the federal judges involved in the scandal because it sheds light on the numerous conflicts in the United States rooted in religion. Two congressmen told me that my congressman (Yvette Clarke, 9th District of New York) should address my concerns. My request to meet with Ms. Clarke or her staff about this matter has been ignored. I filed an ethics complaint against Ms. Clarke with the Ethics Committee on August 31. Since you are a member of this committee, I am asking you to assist me in this matter. What follows is the message I sent to all the churches in Mr. Goodlatte's district.

I am involved in two miracles, or signs, that involves Congressman Bob Goodlatte of the 6th Congressional District of Virginia, who is the Chairman of the House Judiciary Committee. I filed a First Amendment lawsuit against Columbia University for declining my offer to give a lesson/lecture on God's existence. Columbia violated the academic freedom of the Columbia community because there is no other way the students and faculty could learn the rational concept of God and the argument for God's existence. The Stanford Encyclopedia of Philosophy, for example, has three long entries about God's

existence (cosmological, teleological, and ontological) but none of these entries make sense.

Since Columbia is a private college, there is no cause of action. The first miracle is that the U. S. Court of Appeals for the Second Circuit nevertheless agreed to hear my oral argument on January 18, 2018. The podcast is on the Court's website.

The second miracle is that the attorney for Columbia U. announced his appearance for the President of Columbia (Lee Bollinger) one day before Mr. Bollinger read the amended complaint. I filed a motion for a default judgment, which was denied. I then filed a misconduct complaint against the district judge. The Judiciary Counsel of the Second Circuit exonerated the judge in a way that is blatantly dishonest. I then sent a four-page letter addressed to Mr. Goodlatte to every member of the House of Representatives about the scandal.
